OHIO SENATE Committee on State Government Oversight and Reform Minutes November 20, 2013 130th General Assembly

Senator Skindell moved Amendment 1193 (Poll worker obligation to complete provisional ballot form). Senator Brown seconded the motion. The motion was tabled by a vote of 8-3.

Senator Skindell moved Amendment 1194 (Count wrong-precinct/wrong-location provisional ballots if caused by poll worker error). Senator Brown seconded the motion. The motion was tabled by a vote of 8-3.

Senator Skindell moved Amendment 1195 (Provisional ballot counted if the information provided is sufficient to determine the voter's eligibility; remove address and date of birth requirements). Senator Brown seconded the motion. The motion was tabled by a vote of 8-3.

Senator Smith moved Amendment 1191 (List of provisional voters). Senator Brown seconded the motion. The motion was tabled by a vote of 8-3.

Senator Smith moved Amendment 1190 (Provisional voters who have neither ID nor SSN). Senator Skindell seconded the motion. The motion was tabled by a vote of 8-3.

Senator Smith moved Amendment 1189 (Requests to receive absent voter's ballots for all future elections). Senator Skindell seconded the motion. The motion was tabled by a vote of 8-3.

Senator Smith moved Amendment 1192 (Immaterial errors or omissions on elections documents). Senator Brown seconded the motion. The motion was tabled by a vote of 8-3.

Senator Brown moved Amendment 1196 (Online voter registration and absent voter's ballot requests). Senator Smith seconded the motion. The motion was tabled by a vote of 8-3.

Senator Seitz moved that Sub S.B. 216 be favorably reported to the Senate. Senator Uecker seconded the motion. The motion was agreed to by a vote of 8-3.
