TEN BILLBOARDS. MILLIONS OF IMPRESSIONS.

In late January, we placed a series of billboards across the state with one simple message: Abortion is still legal in Ohio. Ten billboards appeared in Akron, Cincinnati, Cleveland, Columbus, Dayton, Toledo, Wheeling, and Youngstown reminding Ohioans, and others commuting to and from the state, that Ohio clinics remain open and services are available to individuals in need of abortion and other reproductive healthcare.

After the near-total abortion bill was signed into law in April of 2019 misinformation spread like wildfire. The good news is, as a result of our lawsuit, a federal judge blocked the law from taking effect in July. Our fight for abortion access continues.



MODERNIZE OHIO'S ELECTIONS

Ohioans need to have an urgent, nonpartisan, consensus-driven conversation about a subject we rarely talk about: our state's woefully lackluster voter participation.

But the fault is not an apathetic electorate. Instead, the root of the problem is Ohio's lack of commonsense modernizations that would make it easier for eligible citizens to register, have their voices heard and their votes counted.

Ohioans deserve an election system geared toward broad inclusion, ensuring that every eligible voter can cast a secure ballot. Fair and inclusive measures include:

- Automatic voter registration for eligible citizens when they interact with the Ohio BMV.
- Early voting with consistent and guaranteed evening and weekend voting hours.
- Rigorous audits to ensure the accuracy and trustworthiness of our results.


All eligible citizens in Ohio should be able to cast a ballot without obstacles or interference.
