HUGE VICTORY FOR TRANSGENDER OHIOANS

After years of advocacy and litigation, an Ohio federal judge, in *Ray v. McCloud*, struck down a discriminatory state policy that prevented Ohio-born transgender people from correcting the gender marker on their birth certificates. The ACLU of Ohio, Lambda Legal, National ACLU, and Thompson Hine LLP successfully represented plaintiffs Stacie Ray, Basil Argento, Ashley Breda, and Jane Doe. The victory in Ohio leaves Tennessee as the last state to deny this right to trans people. *"This ruling affirms that the state must recognize the dignity and true identity of every transgender Ohioan,"* said Elizabeth Bonham, ACLU of Ohio staff attorney. *"Our clients faced years of unlawful discrimination, but we now celebrate their perseverance and this long-awaited victory."*

OHIOANS: IT'S TIME TO END THE DEATH PENALTY

A new poll finds a bipartisan majority of Ohioans want to end the death penalty. The ACLU of Ohio and Ohioans To Stop Executions released a poll in late January showing **59%** of Ohio voters support replacing the death penalty with life in prison without the possibility of parole. **69%** of Democrats and **53%** of Republicans agreed. *"Whether it's racial disparity, fiscal, or innocence concerns, people across the state and across the aisle believe it's time for Ohio to cut ties with the death penalty,"* said Jocelyn Rosnick, ACLU of Ohio policy director.

Two things are certain at the Ohio Statehouse. First, legislators of both parties will express dismay at Ohio's dangerously overcrowded prisons and jails and the billions spent to operate them. Second, legislators will continually support and pass new bills that only contribute to the crisis, negatively impacting Ohio individuals, families, communities, businesses, and taxpayers.
