Releasing Data on Statehouse to Prison Pipeline

On March 27, the ACLU of Ohio released its fifth Statehouse to Prison Pipeline Report, analyzing 10 years' worth of legislative data.

On April 4, the ACLU of Ohio filed an amicus brief to Ohio's 8th District Court of Appeals in a case addressing the improper hiding of police reliance on facial recognition technology when applying for a search warrant.

Lobbying Ohio's Congressional Delegation in D.C.

The first week of May, our Executive Director Ben Guess, Chief Policy and Advocacy Officer Jocelyn Rosnick, and Senior Policy Counsel Patrick Higgins met with members of Ohio's Congressional Delegation on Capitol Hill for the ACLU's Safety Week.

On May 7, we sent a letter to the presidents of Ohio's public colleges and universities urging them to avoid unintentional complicity in President Trump's inhumane and unlawful immigration policies.

Suing Counties over Refusal to Abide by Public Records Law and Provide ICE Contracts On May 20 and August 12, the ACLU filed two separate legal actions before the Ohio Supreme Court, asking that the sheriff's offices in Geauga and Seneca counties comply with Ohio's public records laws and provide ICE contracts.

On May 29, the ACLU of Ohio hosted a drag show in Columbus showcasing performances, storytelling, and community with special co-hosts Nina West and Virginia West.

Expanding Access to Medication Abortions

On July 8, the ACLU of Ohio received a victorious ruling from the Hamilton County Court of Common Pleas, allowing advanced practice clinicians (including Physician Assistants, Nurse Practitioners, and Certified Nurse Midwives) to provide medication abortions.

Care in Columbus

On July 13, we hosted a canvas to collect signatures for the Columbus Safety Collective Campaign – working to place an alternative police emergency response system on the May 2026 municipal ballot to meet the mental health and safety needs of Columbus residents.

On August 20, Governor DeWine sent 150 Ohio National Guard members to Washington D.C. as part of the administration's federal takeover of our nation's capital. The ACLU of Ohio calls on the Governor to bring troops home and cease support of this fake emergency.

Advocating for Student speech in Public Schools

On August 28, we sent a letter to Dublin City Schools regarding its unlawful constraint of student expression during the 2024-2025 school year.
