MY NAME IS GREG CURRY I WAS SERVING TIME AT A PRISON IN SOUTHERN OHIO CALLED "LUKE", IT WAS AT THE TIME (1993) OHIO'S HIGHEST SECURITY PRISON. ON APRIL 11th 1993 SOME KIND OF DISTURBANCE BROKE OUT THAT FOREVER CHANGED MY LIFE & THE LIFE OF MANY PRISONERS & GUARDS, IT ~~WAS~~ ALSO CREATED THE CURRENT PRISON I RESIDE IN CALLED "OHIO'S SUPERMAX".

IN THE AFTERMATH OF THIS DISTURBANCE I WAS INDICTED ON TWO COUNTS OF AGG. MURDER. ME NOR THE LAWYER APPPOINTED TO ME COULD OF FORESEEN THE UNLIMITED RESOURCES PROVIDED FOR THE STATES PURSUIT OF CONVECTIONS, THIS INCLUDE (BUT NOT LIMITED TO) MONEY, ACCESS TO ALL PRISONERS 24/7, "DEAL" MAKING OPTIONS THAT INCLUDED PAROLE RECOMMENDATIONS FOR INMATES THAT WOULD HELP THE STATE PROSECUTE PEOPLE AND "RECOMMENDATIONS" AGAINST PAROLE IF INMATES WOULDN'T HELP THE STATE OR HAD NO INFO TO HELP, THE STATE PROSECUTORS ALSO HAD POWER TO MAKE PRISONERS LIFE EASIER OR HARDER. ~~ON~~ ON THE OTHER HAND THOSE OF US ACCUSED OF CRIMES RECEIVED LAWYERS THAT WAS LIMITED IN DISCOVERY, EXCULPATORY INFO, EXPENSES AND LITTLE TO KNOW ACCESS TO

PRISONERS SPREAD OUT ALL OVER OHIO, SOME OF WHOM WAS HARASSED FOR AGREEING TO EVEN MEET WITH DEFENSE LAWYERS.

I'M NOT PART OF NOR EVER BEEN ACCUSED OF BEING PART OF ANY LEADERSHIP OR DECISION MAKING ROLE IN THIS DISTURBANCE. THE ODD TWIST OF FATE (IF YOU WILL) IS THAT HAD I ANY INFORMATION I COULD OF RECEIVED A DEAL FROM THE STATE, FOR NOT HAVING INFO I WAS PROSECUTED EVEN ACCUSED BY INMATES THAT ADMIT THEIR INVOLVEMENT IN A "DEATH SQUAD" BUT WAS NEVER CHARGED WITH ANYTHING.

SINCE 1993 MY TREATMENT FROM PRISON OFFICIALS HAS BEEN, AT TIMES, CRIMINAL AND ONLY WHEN I RESPOND IN DEFENSE OF MYSELF DOES IT EVER GET A HEARING. CURRENTLY OHIO PRISON OFFICIALS REFUSE TO ALLOW SET-DOWN INTERVIEWS FOR THOSE OF US CONVICTED OF ROOT RELATED OFFENSES WITH VARIOUS MEDIA OUTLETS THAT HAS REQUESTED SUCH INTERVIEWS. WE THINK IT CRUCIAL TO ALLOW THE PUBLIC TO KNOW WHAT HAS BEEN DONE IN THEIR NAME, RECENT CASES SUCH AS AMANDA KNOX OR GEORGE ZIMMERMAN THAT MEDIA PROVIDED DETAILS TO WHILE ALLOWING THE ACCUSED TO HAVE A VOICE GAVE BALANCE TO PUBLIC PERCEPTION.

THE STATE WON'T REVEAL PROSECUTOR

MISCONDUCT NOR THEIR REWARDS FOR IT. THE PRISONERS THAT LIE FOR THE STATE TO RECEIVE EARLY PAROLES AND/OR NO CHARGES WON'T SPEAK TO THE MEDIA OR PUBLIC FOR US BUT MANY STORIES FROM THE PROSECUTORS SIDE HAVE DOMINATED THE PUBLIC NARRATIVE SINCE 1993. THIS MISCONDUCT INCLUDES PROSECUTORS KNOWINGLY LYING & ALLOWING PRISONERS TO LIE TO JURIES ABOUT WHETHER OR NOT THEY RECEIVED A DEAL TO TESTIFY. EVEN WHEN JURY MEMBERS ASKED DIRECTLY WAS DEALS GIVEN BECAUSE THEY FELT IT WOULD MATTER TO THEM AS THE DELIBERATION PHASE BEGAN AND THE JURY WAS CONTINUALLY TOLD "IT WAS NO DEALS GIVEN OUT". ONLY TO HAVE THESE SAME PROSECUTORS ADMIT TO GIVEN OUT DEALS (~~AND~~) ON APPEAL BUT AFTER THOSE JURY MEMBERS WAS LONG GONE. I THINK MY JURY MEMBERS WOULD LOVE TO KNOW THIS AND THAT ONE OF THESE PROSECUTORS WAS REWARDED WITH A JUDGESHIP.

SHOULDN'T THE PUBLIC KNOW WHEN A PUBLIC SERVANT IS BEING REWARDED FOR BAD BEHAVIOUR / CRIMINAL BEHAVIOUR?! SHOULDN'T THERE BE A HEARING ON THE IMPACT THIS CONDUCT HAS ON THE VICTIM OF THIS KIND OF CONDUCT?! MY LIFE, MY CHILDRENS LIFE, MY PARENTS LIFE HAS BEEN CHANGED BY

THESE FALSE CHARGES AND DUE TO MY
PLACEMENT IN HIGH SECURITY AREAS AS
A RESULT OF THESE FALSE CONVECTIONS I'VE
BEEN SUBJECT TO UNTOLD HARASSMENT
WHICH THE PRISON OFFICIALS RATHER NO
ONE EVER HEAR ABOUT OR SEE. THE SINCERITY
ON MY FACE WHILE BEING INTERVIEWED
ABOUT ANY OF THIS.
