

my name is Jason Robb and I am a PRISONER
~~an Ohio death row~~ sentenced to death in the
 state of Ohio for alleged crimes committed during
 the ~~1993~~ APRIL 11 1993 Southern Ohio Correctional
 Facility "Other wise known as Lucasville" uprising.
 but, by design I do not reside on Ohio death
 row, but in solitary confinement for over
 20 years because of my sentence, no other
 prisoners in the state of Ohio have been placed
 into solitary confinement for their sentence of
 death. unfortunately the Department of Corrections
 has place myself and ~~two~~^{three} other men in a
 pre-designated environment of control and
 isolation, and a attempt to silence us from
 speaking out against the miscarriage of
 justice carried out in the name of Ohioians.
 The Ohio Department of Corrections has for the
 past twenty years constructed a myth of
 notoriety ~~to~~ that is manufactured and spoon
 feed to society every year in April; under
 the guise of a "Anniversary" to remember this
 horrific event in Ohio's "History" and to
 remember those lost during the uprising, of
 course the Corrections officials is ~~the~~^{the} front
 on this topic, but there were prisoners who
 lost their lives as well... and those who are
 still in line to die. A lot of people suffered because
 of this uprising, and still do today, everyone
 has had their say about April 11; but
 not the men sentenced for alleged crimes

Their voices have been purposely restricted by state authorities, ask yourself why? yes why would the state of Ohio spend thousands of dollars to suppress these voices? The only defense to this was "Defendants admit that they have consistently denied all members of the press face to face media access to any prisoner convicted of crimes committed during the April 1993 Lucasville uprising due to OPRC's concerns regarding safety and security and the fear that these prisoners would thereby gain a disproportionate degree of notoriety and influence among their fellow inmates, leading to substantial disciplinary problems that could engulf large portions of the prisons."

Remember this has been their reasoning for over 20 years now, but there has been no evidence of their "concerns" to prove their defense and/or reasoning to basically gag us, and deny us our constitutional rights, not to mention our civil rights, but it is not my intent nor do I want to live up to this propaganda of notoriety built up around these so-called "riot leaders" a pre-fabricated term fed to the public to cause immediate distrust and hate towards these men, I only want to dispell this myth that the state has so masterfully designed around us, yes they can keep their myths, I am a human

being, with people who I love and I'm blessed
 that they love and support me in my struggle
 to dispel the myth that CBAKs me, and
 to let people know just what their government
 has done in their name; this is the true
 fear that the government has, when it comes
 to us men sentenced for alleged crimes committed
 during the 1993 KKKsville uprising. After 20
 years of digging and constant battles to suppress
 us, we have come to find ~~find~~ evidence
 that in any other setting should be public information
 under "our" laws, such as numerous state witnesses
 that testified for the government to convict
 and place us on death row, and others to life
 imprisonment, recanted their testimonies, and
 another inmate confessed to a murder that
 others had been previously sentenced to death
 and imprisonment, for, and his testimony clears
 these men of those crimes, but George Skatze
 still sit on death row for this alleged act?
 Also, it has come to light the state ~~has~~ ^{has} gone
 through a process to suppress evidence
 favorable to these men, why. There are numerous
 state witnesses that failed polygraph tests
 but this was also kept from the public, also
 the state helped state witnesses during their
 parole hearings to gain release from prison.
 The same men who the state allowed to put
 perjured testimony before a jury and
 grand jury to gain convictions. it also

Came to light the only piece of evidence
 used during trials that ended in death
~~sentences~~ sentences "Tunel Tape 61" a
 recording done by FBI Agents from a
 bug planted during the uprising, supposedly
 a meeting of the leaders of the uprising
 plotting the murder of a prison guard"
 but after my trial it came to light that
 this tape had ~~no~~ suspicious recording events
 done by a specialist; and then once being
 questioned in court the state refused to
 play it in Carlos Sanchez trial so no further
 questioning or review would be done to
 this tape; but the damage had been done
 as numerous inmates transcribed this tape
 for the state inmate witnesses, then who
 testified to its truthfulness, was; but
 it's come to light that this tape that all these
 state witnesses tailored their testimonies
 around is in question as to its truthfulness
 and being tampered with by the state to
 secure convictions of death. These are just
 some of the things the state wishes to suppress
 from Ohio citizens, in order to keep the
 light from shining upon the dirty and
 corrupt tactics state authorities orchestrated
 to convict and cover up and contain these
 acts from ever being laid before society
 to show just how unjust the justice system
 can be when absolute power corrupts
