Democracy is under attack in Ohio. On May 10, a Republican supermajority in the Ohio Legislature passed

Senate Joint Resolution 2, an extreme, undemocratic proposal to increase the passage threshold for ballot measures from 50% to a supermajority of 60%, while also making it virtually impossible to qualify for the ballot in the first place. This extreme, undemocratic proposal will now be before voters on an August Special Election ballot. The irony is that just in December, the General Assembly specifically eliminated August statewide special elections due to abysmally low voter turnouts and excessive costs to Ohio taxpayers. It is brazenly manipulative and hypocritical to put such important matters on the ballot when most voters are unaware an election is even taking place. Alas, their diabolical plan, all along, was to put this unlawful measure on the ballot, thinking that we, the people, wouldn't be paying attention. We look forward to proving them wrong at the polls on **Tuesday, August 8.**

Here's the big takeaway: If passed, this radical proposal will allow 40% of Ohio voters to block proposals that 59.9% of Ohioans support, most especially the reproductive freedom measure which will come before voters on Tuesday, November 7.

As a result of our extremely gerrymandered legislative districts, the laws that come out of the Statehouse do not reflect the will of most Ohioans. This is exactly why Ohioans need to have recourse, by taking issues they care about directly to the people. The opposition is rigging the system because they know they cannot win. This is an all-out power grab. All of our rights are now on the line.
